Former chief deputy prosecutor, head of the Homicide Unit, Major Crime Division, head of the Criminal Division, county counselor, chief legal advisor to the prosecuting attorney, county sheriff, the Department of Corrections in Jackson County, Missouri and BDIC co-founder/partner. 1 hour
